Roles and Responsibilities

Community Education Council (CEC)

- >The CEC is responsible for approving zoning proposals.

Community Superintendent

- >The Community Superintendent is responsible for collecting public feedback and presenting the zoning proposal to the CEC.

The Office of Portfolio Planning

- >Portfolio Planning works with the CEC and the Superintendent to develop the zoning proposal.

The overall goal of zoning proposals is to alleviate over-enrollment in existing schools, support enrollment at new schools, and balance enrollment across the district.

Facts About Rezoning

- Pre-Kindergarten enrollment will not be impacted by the rezoning proposal.
- Younger siblings will be given first preference into schools where their siblings are attending elementary grades.

Frequently Asked Questions

- Where do the numbers come from?
 - Zone lines are based on the number of students living within the zone.
 - Projections are based on historical patterns and are updated based on expected changes to where students live or changes in the schools.
 - This proposal assumes a projection of Kindergarten students based on historical enrollment trends.
- What effect does this have on middle school zones?
 - This rezoning proposal does not impact middle school zone lines at all. As a city-wide policy, sibling preference does not apply at the middle school level.

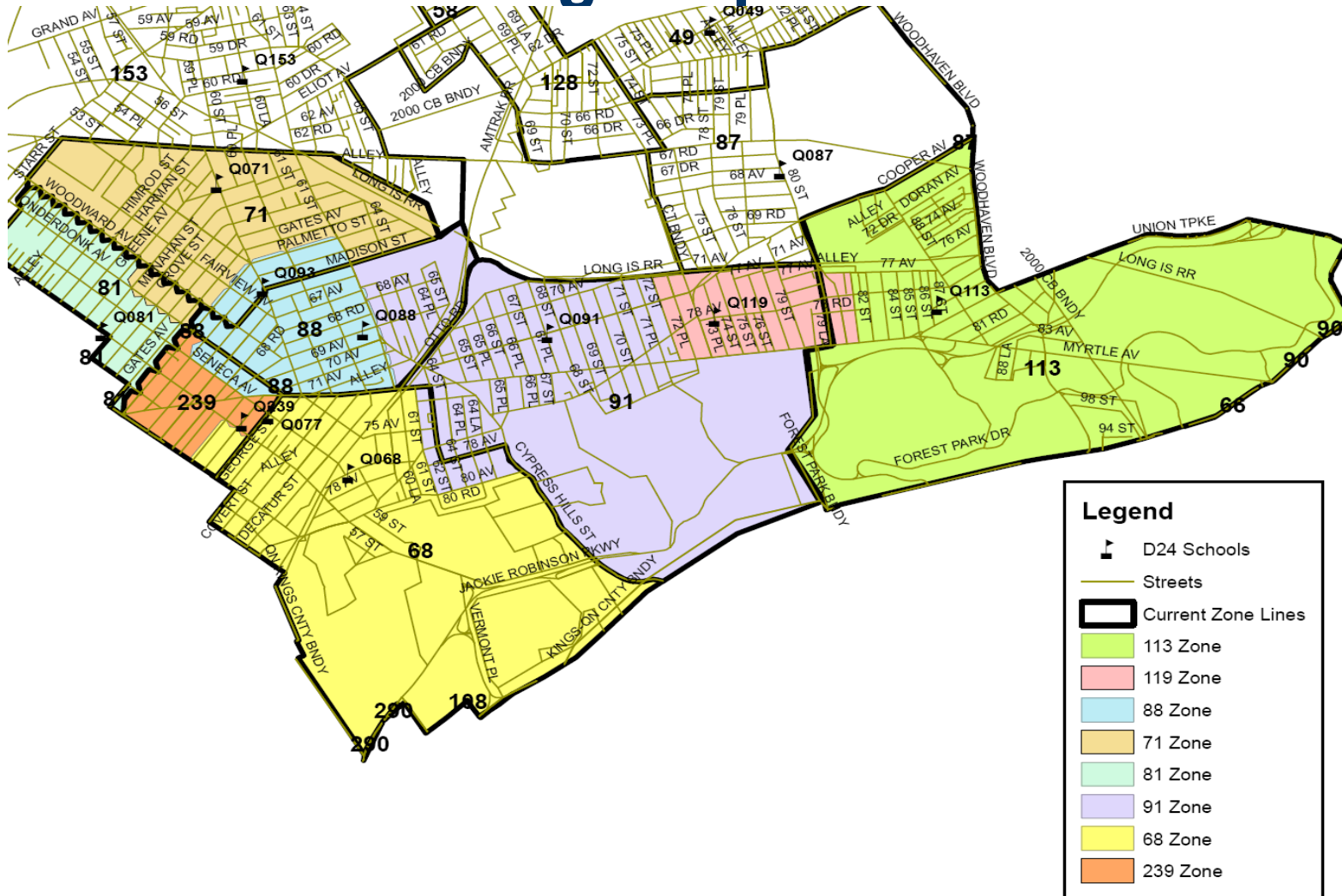
Proposal Goals

- Maintain the size of enrollment at all other impacted schools.

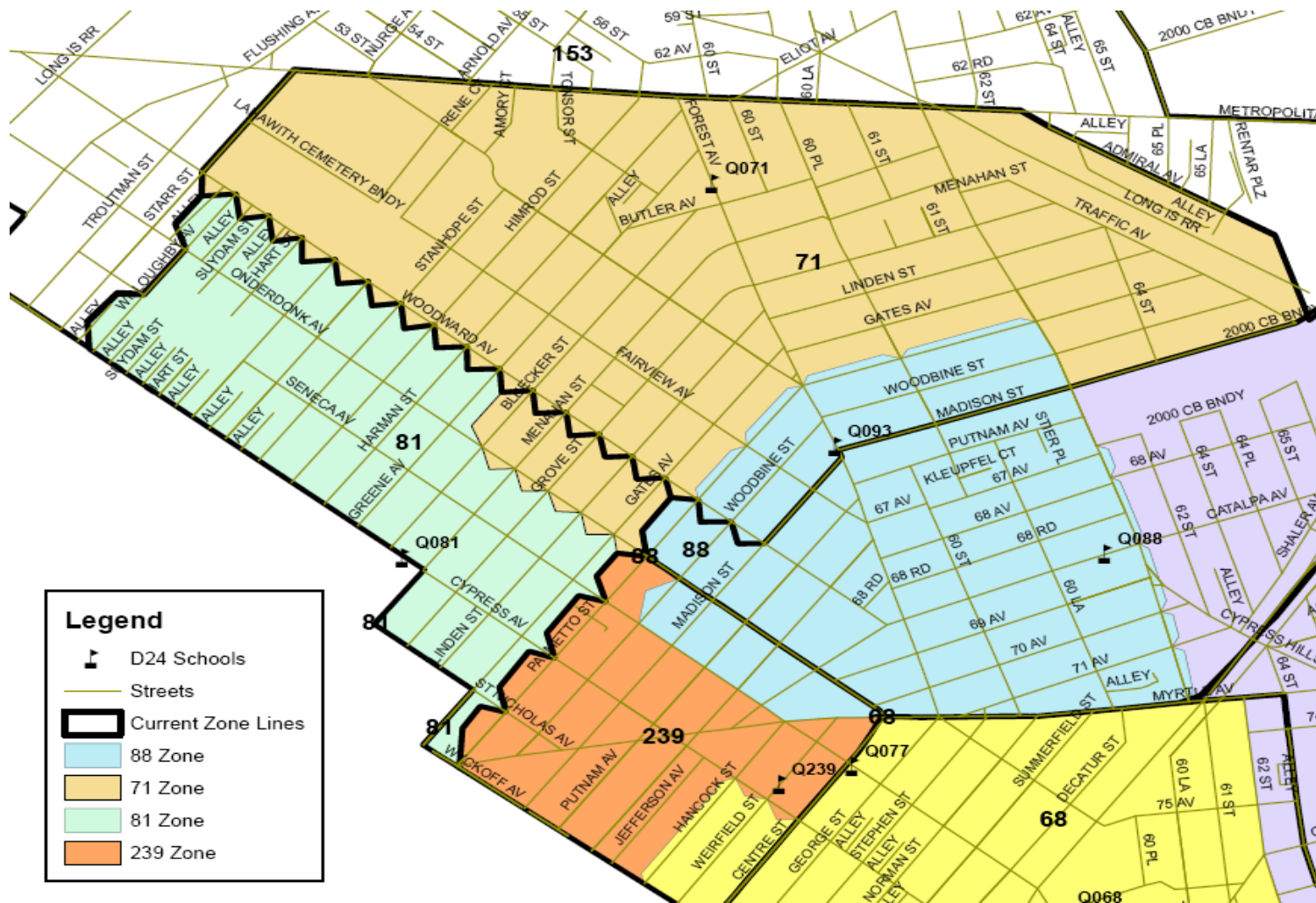

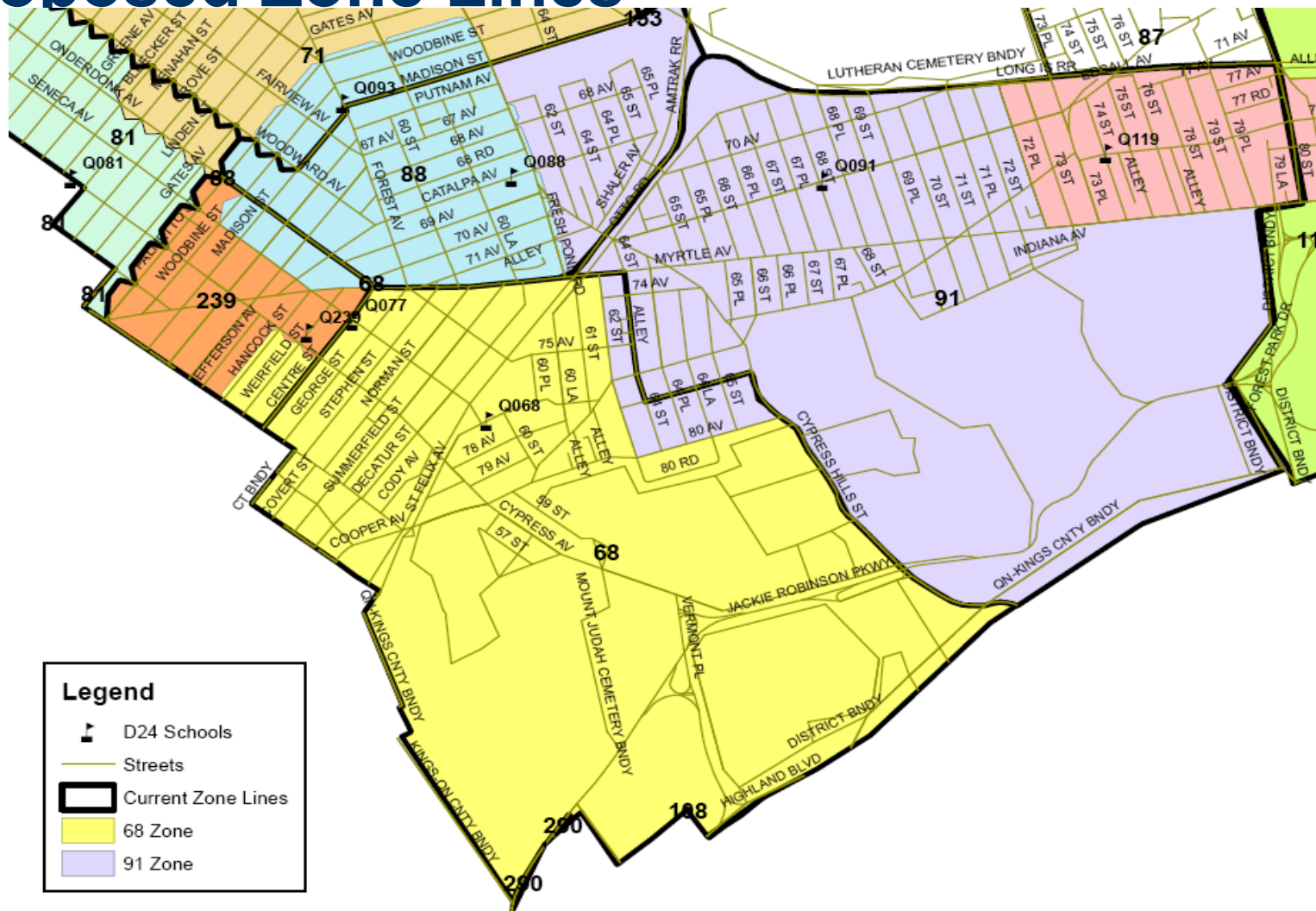
District 24 Rezoning Proposal



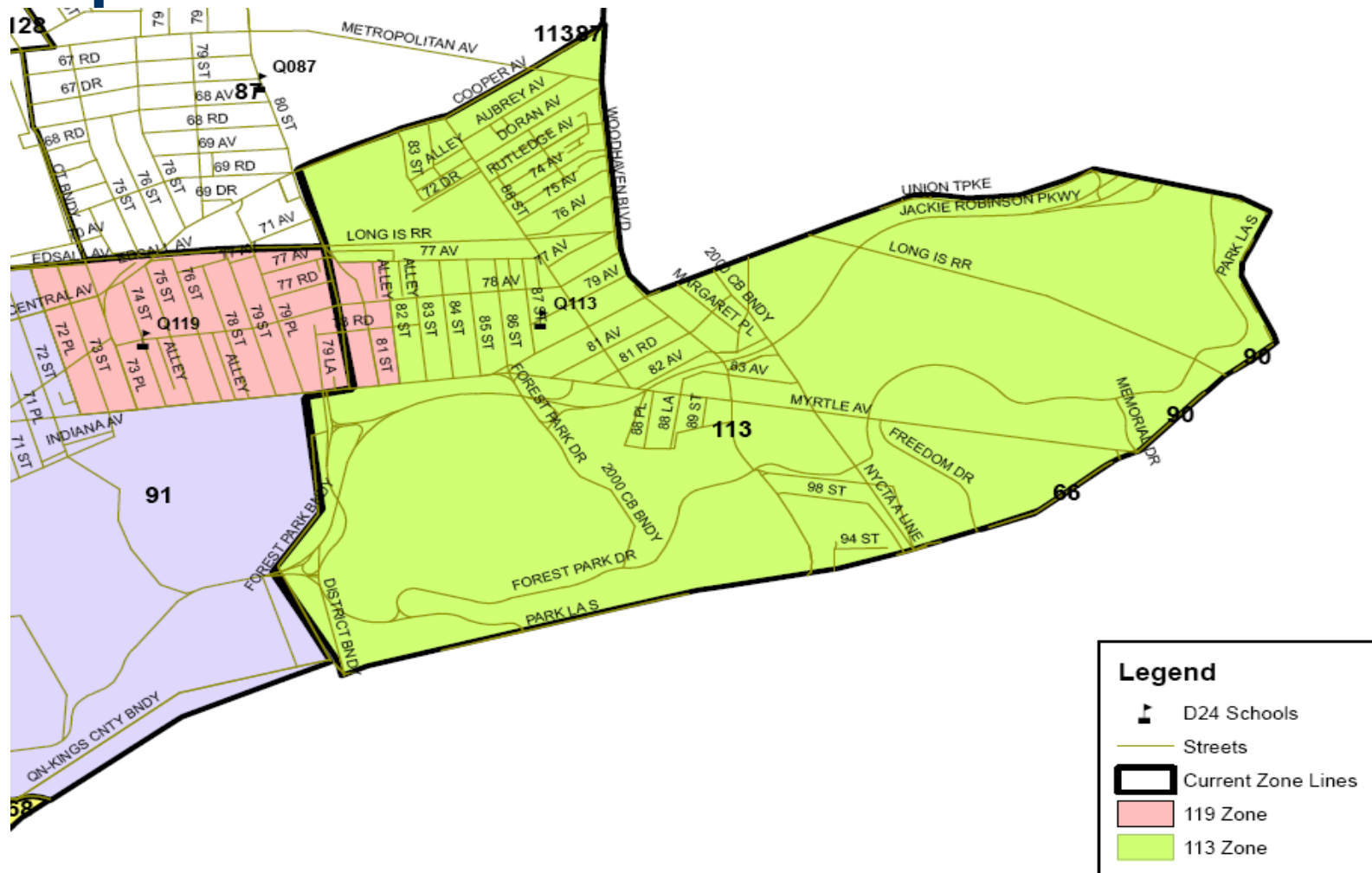
Proposed Zone Lines
