

District 30 Elementary Re-Zoning Proposal

OVERVIEW

ROLES and RESPONSIBILITIES:

- Community Education Council (CEC): responsible for voting on zone lines.
- Community Superintendent: responsible for collecting public feedback and presenting the re-zoning proposal to the CEC.
- The Office of Portfolio Planning: works with the Community Superintendent and the CEC to develop the re-zoning proposal.

GUIDING PRINCIPLES:

- Pending approval from the CEC, proposed changes take effect for September 2011 enrollment.
- The proposed changes impact only new incoming Kindergarteners or new students to the system.
 - All students (K-5) currently enrolled in any school may remain in their school until graduation.
 - All students currently enrolled in an ECC (PS 228, PS 222) may attend grades 3-5 at the school they are *currently* zoned for.
- Sibling enrollment policies remain the same.
- This proposal assumes enrollment growth based on historical enrollment trends.

Goals in Rezoning:

The primary goals in this proposal include: alleviating over-enrollment and equalizing building utilization, supporting school choice and supporting new schools.




GENERAL THINGS TO CONSIDER

- **Timeline:** To impact next year's incoming Kindergarten class, a rezoning proposal for ES zones is ideally approved by the CEC no later than December/January (prior to the start of citywide K registration).
- **Enrollment Trends and Data:** information from the most recent Kindergarten registration process and/or the most recent audited register are used in the analysis, alongside historical data and current building capacity information. Population density plays a factor in zone boundaries, and may vary block by block.
- Overall district planning: district wide plans, trends, or portfolio changes are considered when a rezoning proposal is under consideration.
- **CEC Zoning subcommittee:** responsible for identifying or clarifying goals, engaging with the community for feedback, and in the overall planning process.



CURRENT ELEMENTARY SCHOOL ZONES



SUMMARY OF PROPOSED CHANGES

This proposal results in the following:

- 1. Create a new zone for PS 280
- 2. Reduce zones for PS 69 and PS 92
- 3. Increase access to Early Childhood Centers (ECCs) PS 222 and PS 228
 - Residents of the proposed zone for PS 69 would have the option to attend K-2 at PS 222 (ECC).
 - Residents of the proposed zone for PS 148 would have the option to attend K-2 at PS 228 (ECC).
 - Students who begin dual language programs at the ECCs will have the opportunity to continue with the dual language programs in grades 3-5.
- 4. Areas of District 30 that are zoned to District 24 are returned to District 30


REMINDER: (from slide 1)

- The proposed changes impact only new incoming Kindergarteners or new students to the system for September 2011 enrollment.
 - All students currently enrolled (K-5) in any school may remain in their school until graduation.
 - All students currently enrolled in an ECC (PS 228, PS 222) may attend grades 3-5 at the school they are currently zoned for.
