

Dear Parent/Guardian:

New York City Public Schools is responsible for conducting evaluations, developing Individualized Education Services Plans (IESPs) and Services Plans (SPs), and providing special education services to students with disabilities who are parentally-placed in private or religious non-public schools located in New York City. Our records show that you have placed your child in a non-public school at your own expense. **If you would like your child to receive special education services while enrolled in a New York City non-public school next school year, you must sign and mail or email this form to the <u>Committee on Special Education (CSE)</u> by June 1, 2023.**

If your child will attend a non-public school **outside** of New York City, please note the following:

- The school district where the school is located will be responsible for providing special education services, conducting individual evaluations and conducting IEP meetings.
- We must have your written consent in order to provide information (such as your child's IEP/IESP) to the school district where the non-public school is located so that they can arrange for the recommended special education services.
- You must request services from the district where the school is located by June 1st. The personnel and locations for the delivery of these services will be determined by that school district.
- If the non-public school where you placed your child is located in another state, your child might not be entitled to all of their IEP services. You will need to check with the school district where your child's non-public school is located for more information.
